RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE OF TRADEMARK SECURITY INTEREST (“**Release**”), is made and effective as of March 26, 2024 and granted by BANK OF AMERICA, N.A., as Administrative Agent (the “**Grantee**”), located at 555 California Street, 4th Floor, San Francisco, CA 94104 in favor of PILOT TRAVEL CENTERS LLC, a Delaware limited liability company, and its successors, legal representatives and assignees (collectively, the “**Grantor**”).

WHEREAS, Grantor entered into (a) that certain Collateral Agreement, dated as of October 8, 2008 (as amended, restated, amended and restated, modified, extended, restated, replaced or supplemented or otherwise modified from time to time prior to the date hereof, the “**2008 Collateral Agreement**”), (b) that certain Collateral Agreement, dated as of June 30, 2010 (as amended, restated, amended and restated, modified, extended, restated, replaced or supplemented or otherwise modified from time to time prior to the date hereof, the “**First Collateral Agreement**”), (c) that certain Second Amended and Restated Collateral Agreement, dated as of October 3, 2014 (as amended, restated, amended and restated, modified, extended, restated, replaced or supplemented or otherwise modified from time to time prior to the date hereof, the “**Second A&R Collateral Agreement**”) and (d) that certain Third Amended and Restated Collateral Agreement, dated as of December 18, 2019 (as amended, restated, amended and restated, modified, extended, restated, replaced or supplemented or otherwise modified from time to time prior to the date hereof, the “**Third A&R Collateral Agreement**” and, together with the 2008 Collateral Agreement, the First Collateral Agreement and the Second A&R Collateral Agreement, the “**Collateral Agreements**”), with Grantee;

WHEREAS, in connection with the 2008 Collateral Agreement, the Grantor executed and delivered to Grantee that certain Notice of Grant of Security Interest in Trademarks, dated as of October 8, 2008 (the “**2008 Trademark Security Agreement**”);

WHEREAS, in connection with the First Collateral Agreement, the Grantor executed and delivered to Grantee that certain Notice of Grant of Security Interest in Trademarks, dated as of June 30, 2010 (the “**2010 Trademark Security Agreement**”);

WHEREAS, in connection with the Second A&R Collateral Agreement, the Grantor executed and delivered to Grantee that certain Notice of Grant of Security Interest in Trademarks, dated as of October 3, 2014 (the “**2014 Trademark Security Agreement**”);

WHEREAS, in connection with the Third A&R Collateral Agreement, the Grantor executed and delivered to Grantee that certain Notice of Grant of Security Interest in Trademarks, dated as of December 18, 2019 (the “**2019 Trademark Security Agreement**” and, together with the 2008 Trademark Security Agreement, the 2010 Trademark Security Agreement and the 2014 Trademark Security Agreement, the “**Trademark Security Agreements**”);

WHEREAS, pursuant the Trademark Security Agreements, the Grantor pledged and granted to Grantee a security interest in and to all of the right, title and interest of the Grantor in, to and under the Grantor's trademarks and trademark applications set forth on Schedule 1 attached hereto (the "**Trademark Collateral**");

WHEREAS, the 2008 Trademark Security Agreement was recorded at the United States Patent and Trademark Office at Reel 3867/ Frame 0526 on October 8, 2008;

WHEREAS, the 2010 Trademark Security Agreement was recorded at the United States Patent and Trademark Office at Reel 4285/ Frame 0071 on September 28, 2010;

WHEREAS, the 2014 Trademark Security Agreement was recorded at the United States Patent and Trademark Office at Reel 5378/ Frame 0642 on October 9, 2014;

WHEREAS, the 2019 Trademark Security Agreement was recorded at the United States Patent and Trademark Office at Reel 6827/ Frame 0205 on December 27, 2019; and

WHEREAS, the Grantor has requested that Grantee execute this Release in order to accomplish and evidence the release and reassignment of any and all right, title and interest Grantee may have in the Trademark Collateral pursuant to the Trademark Security Agreements.


NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby states as follows:

1. Release of Security Interests. Grantee, its successors, legal representatives and assigns, terminates, releases and discharges any and all liens and its security interest in, to and under the Trademark Collateral, and all other right, title, and interest in and to the Trademark Collateral, including the trademarks referred to on Schedule 1 hereto, and reassigns to the Grantor any and all such right, title and interest that it may have in the Trademark Collateral.
2. Further Assurances. Grantee agrees to execute, acknowledge, procure and deliver to the Grantor any and all further documents or instruments and do any and all further acts which the Grantor (or its respective agents, designees or assignees) reasonably request in order to confirm, effectuate or record this Release and the Grantor's (or its assignees') right, title and interest in and to the Trademark Collateral.
3. Governing Law. This Release shall be governed by, and construed in accordance with, the laws of the State of New York.
