## RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This Release of Security Interest in Intellectual Property (this “Release”) is made as of April [9], 2024, by PNC BANK, NATIONAL ASSOCIATION (the “Secured Party”), in favor of VITAL FARMS, INC., a Delaware public benefit corporation (the “Debtor”).

### Recitals

WHEREAS, pursuant to that certain Intellectual Property Security Agreement (Trademarks and Patents), dated as of October 4, 2017 (as the same may have been amended, modified, restated, replaced or supplemented from time to time, the “Security Agreement”), recorded with the U.S. Patent and Trademark Office on June 28, 2018, at Reel/Frame No. 006366/0332 (Trademarks), the Debtor granted and pledged to Secured Party a security interest in all of the Debtor’s right, title and interest in, to and under the Debtor’s trademarks (including without limitation those trademarks described on Exhibit A hereto), service marks, domain names, trade dress, logos, designs, slogans, trade names, business names, corporate names and other source identifiers, whether registered or unregistered, together, in each case, with the goodwill symbolized thereby (collectively, the “Intellectual Property Collateral”).

WHEREAS, the Debtor has requested and Secured Party has agreed to release its security interest in and to the Intellectual Property Collateral and terminate the Security Agreement.

### Agreement

Now, therefore, Secured Party terminates and releases all of its right, title and interest in, to and under the Intellectual Property Collateral and terminates the Security Agreement, and reassigns, grants and conveys to the Debtor all right, title, and interest of Secured Party in or to the Intellectual Property Collateral.

Secured Party hereby authorizes the Debtor or the Debtor’s authorized representative to (i) record this Release with the U.S. Patent and Trademark Office, and/or (ii) otherwise record or file this Release in the applicable governmental office or agency.

Following the date hereof, the Secured Party agrees to execute and deliver such further instruments and take such additional action as the Debtor, or its successor in interest, or the United States Patent and Trademark Office may reasonably request to effect or consummate the transactions contemplated hereby.
