**TERMINATION AND RELEASE OF
PATENT COLLATERAL SECURITY AGREEMENT AND TRADEMARK COLLATERAL
ASSIGNMENT AND SECURITY AGREEMENTS**

THIS TERMINATION AND RELEASE OF PATENT COLLATERAL SECURITY AGREEMENT AND TRADEMARK COLLATERAL ASSIGNMENT AND SECURITY AGREEMENTS (“Release”) is made as of April 23, 2024, by THE CIT GROUP/COMMERCIAL SERVICES, INC. (the “Lender”), in favor of JETSON ELECTRIC BIKES LLC, a New York limited liability company (“Jetson”) and JIPEE LLC, a New York limited liability company (“Jipee”, together with Jetson, “Grantors” and each a “Grantor”).

WHEREAS, Jetson entered into that certain Trademark Collateral and Security Agreement, dated September 15, 2022, with Lender, notice of which was recorded with the trademark division of the United States Patent and Trademark Office (“USPTO”) on September 21, 2022, at reel/frame 7851/0965 (the “Jetson Trademark Agreement”) and that certain Patent Collateral Security Agreement, dated September 15, 2022, with Lender, notice of which was recorded with the patent division of the USPTO on September 21, 2022, at reel/frame 061502/0194 (the “Jetson Patent Agreement”).

WHEREAS, Jipee entered into that certain Trademark Collateral and Security Agreement, dated September 15, 2022, with Lender, notice of which was recorded with the trademark division of the USPTO on September 21, 2022, at reel/frame 7853/0420 (the “Jipee Trademark Agreement” and together with Jetson Trademark Agreement and Jetson Patent Agreement, collectively, the “IP Security Agreements”). Capitalized terms used but not otherwise defined herein have the meanings given to them in the IP Security Agreements.

WHEREAS, Grantors granted to Lender (and its successors and permitted assigns), under the terms of the IP Security Agreements, a security interest in favor of Lender, in and to all of their right, title and interest in and to (i) the collateral, including without limitation the Patents listed in Schedule A (the “Patents”) and the Trademarks listed in Schedule B (the “Trademarks”, collectively with the Patents, the “Collateral”) and all of the goodwill of the business connected with the use of, and symbolized by, each Collateral, (ii) all reissues, continuations or extensions of the foregoing, (iii) all licenses or other similar rights provided or granted to Grantors in or with respect to the Collateral that is owned or controlled by any other person and any other license or other similar rights provided or granted by Grantors to any other person in or with respect to the Collateral owned or controlled by Grantors and (iv) all products and proceeds of the foregoing, including without limitation any claim by a Grantor against third parties for past, present or future infringement or dilution of any Collateral.

WHEREAS, Lender has agreed to terminate and release its security interest in all such Collateral as herein provided.

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Lender hereby absolutely, unconditionally and irrevocably (a) releases, terminates and discharges its security interest in the Collateral, including without limitation the Patents and Trademarks listed on the Schedules attached hereto and made a part hereof, (b) terminates the IP Security Agreements and (c) assigns, transfers and conveys to Grantors any right,

title or interest, including the security interest, it may have in the Collateral. Grantors, or any successor to Grantors (including any person or entity hereafter having any right, title, or interest in or to the Collateral), are hereby authorized to record this Release with the USPTO. Lender agrees to perform all further acts and execute and deliver all further documents and/or instruments that may be reasonably necessary to carry out the provisions of this Release. Lender hereby represents and warrants that it has full authority to execute and deliver this Release. This Release shall be governed by and construed in accordance with the law of the State of New York and shall be binding upon the Lender's representatives, successors, assigns and transferees.
