TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS

This Termination and Release of Security Interest in Trademarks ("Release") is made as of, June 4, 2024, by DEUTSCHE BANK TRUST COMPANY AMERICAS, a New York banking corporation (in such capacity, together with its successors and assigns, "Administrative Agent") in favor of CONVERGEONE, INC., a Minnesota corporation with an address at 10900 Nesbitt Ave. South, Bloomington, Minnesota 55437 (the "Grantor").

WITNESSETH:

WHEREAS, the Grantor entered into a certain trademark security agreement dated July 10, 2020 (the "Trademark Security Agreement") with Administrative Agent, notice of which was recorded by the United States Patent and Trademark Office on July 13, 2020 at Reel 6997, Frame 0307.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, the Grantor granted the Administrative Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the "Security Interest") in favor of the Administrative Agent, in all of such Grantor's right, title and interest in and to the Trademark Collateral, including without limitation the Trademarks listed in Schedule A.

WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges (in each case, without any recourse to, or any representation or warranty by, the Administrative Agent) any and all of its interest in the Trademark Collateral of the Grantor, and assigns, transfers and conveys to Grantor (in each case, without any recourse to, or any representation or warranty by, the Administrative Agent) any interest in such intellectual property, including the Security Interest.
